

This Memorandum of Understanding (MOU) represents a formal agreement between Kumari Vidyavati Anand D.A.V. College for Women, Karnal, Haryana (a higher education institution, hereinafter referred to as "the College") and houseofnail_2970, Karnal, Haryana (hereinafter referred to as "the Studio").

- **Internship and Practical Skill Enhancement:** Both parties will work together to develop internship and skill based learning opportunities that provide the students with hand – on experience in the field of Nail Art and Cosmetology.
- **Guest Lectures and Workshops:** Various guest lectures, workshops, seminars and professional development sessions, will be organized by the Studio for practical learning of Nail Art in the field of Cosmetology and the College will provide adequate space and technical assistance.
- **Professional Mentorship and Guidance:** The college students interested in pursuing careers in the field of cosmetology especially in Nail Art, offering career advice, networking opportunities and professional development resources will be guided and mentored by both the parties.
- **Community Outreach:** Both parties will collaborate in community outreach activities and promotion campaigns aimed at creating innovative ideas about cosmetology and focusing on Nail Art.

Purpose and Scope:

- The purpose of this MOU is to establish a collaborative relationship between the College and the Studio and provide professional guidance and expertise in the field of Cosmetology.
- The scope of this MOU includes imparting knowledge about Nail Art to college students, faculty and staff.

Responsibilities:

- The college shall support the organization to deliver demonstration services related to Nail Art.
- Maintain confidentiality and adhere to professional standards.

This MOU shall be in the effect from October 6, 2025 and will be for a period of three years and can be extended further by mutual consent.
