- Professional Mentorship and Guidance: As a mentor, you will provide guidance, support, and mentorship to our students interested in pursuing careers in baking, chocolate making, offering career advice, networking opportunities, professional development resources.
- Community Outreach and Bakery & Chocolate Making: Together we will collaborate in community outreach activities and promotion campaigns aimed at creating innovative ideas about bakery, chocolates, and other nutritive baked products in the local community.

Purpose and Scope:

- The purpose of this MOU is to establish a collaborative relationship between the Organization and the College and provide professional guidance and expertise in the field of bakery and chocolate making.
- The scope of this MOU includes baking of sweet and salty food items, variety of chocolates, and various other baked products to college students, faculty and staff.

Responsibilities:

- The college shall support the organization to deliver demonstration services related to baking and chocolate making.
- Maintain confidentiality and adhere to professional standards.

This MOU shall be in the effect from June 24, 2025 and will be for a period of three years and can be extended further by mutual consent.

- Both parties agree to maintain the confidentiality of any non – public information shared during this collaboration.
