5. Branding and Promotion

TIG shall be permitted to distribute branded merchandise, brochures, and educational kits during college events with prior approval. Both parties may mutually promote activities under this collaboration.


6. Exclusivity Clause

11. Dispute Resolution


Any disputes arising out of this MoU shall be resolved amicably through mutual discussions.


